Caste, Income and Domicile Certificates (for reserved category candidates) in original issued by competent authority; Original certificate of Disabilities in terms of the provisions of the persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act., 1995, issued by the Medical Board (if Applicable);
7. An A/C Payee Bank Draft for Rs. 1,00,000.00/- (Rs. One Lac only) for General / All Backward Classes Candidates and Rs. 55,000/- (Rs. Fifty Five Thousand only) for SC / ST candidates respectively in favour of the Director, L. N. Mishra Institute of Economic Development and Social Change, Patna be deposited at the time of admission, the amount being 1st installment of Course Fee and Development Charge.
