However, reserved category candidates under EWS will have to furnish relevant certificates issued by the competent authority. Without furnishing Caste and related certificate at the time of admission, candidate's candidature will be considered as General Category subject to availability of seat.

Further, all the candidates who have been **provisionally selected for admission subject to fulfillment of eligibility criteria**, will have to furnish the following documents in original as well as one set of self attested photocopy of the original documents at the time of admission for verification & submission:

2. College Leaving Certificate (CLC, if applicable);
3. Migration Certificate;
4. Mark-Sheets of Class X, +2/Intermediate & Graduation;
5. Relevant Certificate for reserved category candidates under EWS.

Caste, Income (only for EBC & BC candidates) and Domicile Certificates (for reserved category candidates) in original issued by competent authority (not below the rank of SDM); Original certificate of Disabilities in terms of the provisions of the persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act., 1995, issued by the Medical Board (if Applicable);
7. An A/C Payee Bank Draft for Rs. 57,000.00/- (Rs. Fifty Seven Thousand only) for General / All Backward Classes Candidates and Rs. 36,000/- (Rs. Thirt Six Thousand only) for SC / ST candidates respectively in favour of the **Director, L. N.
