Without furnishing Caste and related certificate at the time of admission, candidate's candidature will be considered as General Category subject to availability of seat.

7. An A/C Payee Bank Draft for Rs. 55,000.00/- (Rs. Fifty Five Thousand only) for General / All Backward Classes Candidates and Rs. 35,000/- (Rs.
