Caste, Income (only for EBC & BC candidates) and Domicile Certificates (for reserved category candidates) in original issued by competent authority (not below the rank of SDM); Original certificate of Disabilities in terms of the provisions of the persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act., 1995, issued by the Medical Board (if Applicable);
7. An A/C Payee Bank Draft for Rs. 57,000.00/- (Rs. Fifty Seven Thousand only) for General / All Backward Classes Candidates and Rs. 36,000/- (Rs. Thirt Six Thousand only) for SC / ST candidates respectively in favour of the **Director, L. N. Mishra Institute of Economic Development and Social Change payable at Patna** be deposited at the time of admission, the amount being 1st installment of Course Fee and Development Charge.
