Caste, Income (only for EBC & BC candidates) and Domicile Certificates (for reserved category candidates) in original issued by competent authority (not below the rank of SDM); Original certificate of Disabilities in terms of the provisions of the persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act., 1995, issued by the Medical Board (if Applicable);
7. An A/C Payee Bank Draft for Rs. 72000/- (Rs. Seventy Two Thousand only) for General / All Backward Classes Candidates and Rs. 46,000/- (Rs. Forty Six Thousand only) for SC / ST candidates respectively in favour of the Director, L. N. Mishra Institute of Economic Development and Social Change payable at Patna be deposited at the time of admission, the amount being 1st installment of Course Fee and Development Charge.
