Caste, Income (only for EBC & BC candidates) and Domicile Certificates (for reserved category candidates) in original issued by competent authority (not below the rank of SDM); Original certificate of Disabilities in terms of the provisions of the persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act., 1995, issued by the Medical Board (if Applicable);
7. An A/C Payee Bank Draft for Rs. 73500/- (Rs. Seventy Two Thousand Five hundred only) for General / All Backward Classes Candidates and Rs. 46,750/- (Rs. Forty Six Thousand seven Hundred Fifty only) for SC / ST candidates respectively in favour of the Director, L. N.
