7. An A/C Payee Bank Draft for Rs. 70000/- (Rs. Seventy Thousand only) for General / All Backward Classes Candidates and Rs. 45,000/- (Rs. Forty Five Thousand only) for SC / ST candidates respectively in favour of the **Director, L. N. Mishra Institute of Economic Development and Social Change payable at Patna** be deposited at the time of admission, the amount being 1<sup>st</sup> installment of Course Fee and Development Charge.
