7. An A/C Payee Bank Draft for Rs. 1,11,500.00/- (Rs. One Lac Eleven Thousand Five hundred only) for General / All Backward Classes Candidates and Rs. 65,750/- (Rs. Sixty Five Thousand seven hundred fifty only) for SC / ST candidates respectively in favour of the Director, L. N. 
