Opportunities, Protection of Rights & Full Participation) Act., 1995, issued by the Medical Board (if Applicable);

7. An A/C Payee Bank Draft for Rs. 1,10,000.00/- (Rs. One Lac Ten Thousand only) for General / All Backward Classes Candidates and Rs. 65,000/- (Rs.
