Caste, Income (only for EBC & BC candidates) and Domicile Certificates (for reserved category candidates) in original issued by competent authority (not below the rank of SDM); Original certificate of Disabilities in terms of the provisions of the persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act., 1995, issued by the Medical Board (if Applicable);
7. An A/C Payee Bank Draft for Rs. 71500/- (Rs, Seventy One Thousand Five Hundred only) for General / All Backward Classes Candidates and Rs. 45,750/- (Rs. Forty Five Thousand seven hundred fifty only) for SC / ST candidates respectively in favour of the Director, L. N. 
